Liability Agreement

Please initial each line to indicate you have read and understood the information provided.

____ I understand and agree that in admitting my dog to the use of its facility, Walks and Wags has relied on my representation that my dog is in good health and has not

harmed or shown aggressive or threatening behavior towards any person or any other dog.

____ I understand and agree that the staff of Walks and Wags is not engaged in the practice of veterinary medicine.

____ I understand and agree that Walks and Wags, its staff and volunteers, will not be liable for any problems that arise out of my or my dog's use of Walks and Wags facilities and

I hereby release them from liability of any kind whatsoever regarding my dog(s) attendance and participation at Walks and Wags.

____ I understand that I am solely responsible for any harm caused by my dog(s) while my dog is utilizing the facilities of Walks and Wags. This includes any harm to persons and/or other dogs as well as to the physical property of Walks and Wags.

____ I understand and agree that any problems that develop with my dog will be treated as deemed best by the staff and volunteers of Walks and Wags, in their sole discretion. I assume full financial responsibility for any expenses involved including injuries to persons and/or dogs, and damages to the facility.

____ I understand that if an injury caused by my dog or to my dog will only be treated if it is considered to be serious as determined by Walks and Wags staff in its sole discretion. If treatment is administered, I accept full responsibility for the financial obligation of treatment to my dog and any dog injured as a result of my dog's behavior.

____ I understand that I am responsible for paying 50% of the cost of a scheduled appointment if I cancel with less than 24 hour notice.

____ I understand a late fee will be charged for any daycare pickups past regular business hours. The fee is \$1 per minute payable before the next day of daycare. Additional daycare will not be provided until all late fees are paid in full. Three late pickups are grounds for re-evaluation of our daycare relationship. Please allow for extra travel time or arrange for an alternate person to pick up your pooch in case of bad weather, traffic, work relations, or other emergencies.

____ I understand and agree that there are inherent risks to be associated with the use of the Walks and Wags facilities arising out of or associated with use and conditions, such as swimming, wet floors, exercise mats, agility equipment, and other dogs. In consideration for Walks and Wags granting me permission to use these facilities, I agree to release Walks and Wags from liability arising out of or associated with such use, and hereafter waive any and all claims which may arise out of or be associated with such permissive use of the Walks and Wags facilities.

____ I understand and agree that children must be under parental control at all times and that there are inherent risks for children associated with the use of the Walks and Wags facilities arising out of or associated with use and conditions, such as swimming, wet floors, exercise mats, agility equipment, and other dogs. In consideration for Walks and Wags granting me permission to use these facilities, I agree to release Walks and Wags from liability arising out of or associated with such use, and

hereafter waive any and all claims which may arise out of or be associated with such permissive use of the Walks and Wags facilities.
